# PROPOSALS FOR RE-ELECTION OF DIRECTORS, GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES AND NOTICE OF ANNUAL GENERAL MEETING

#### 1. INTRODUCTION

The purpose of this circular is to provide you with information regarding certain resolutions to be proposed at the AGM to enable you to make an informed decision on whether to vote for or against those resolutions.

#### 2. RE-ELECTION OF DIRECTORS

The Board currently consists of five Directors, including one Non-executive Director, namely Mr. Ho, Lawrence Yau Lung (Chairman), one Executive Director, namely Mr. Wang, John Peter Ben (Deputy Chairman) and three Independent Non-executive Directors, namely Mr. Tsui Yiu Wa, Alec, Mr. Pang Hing Chung, Alfred and Dr. Tyen Kan Hee, Anthony.

#### LETTER FROM THE BOARD

According to Clause 87 of the Bye-laws, at each annual general meeting, one third of the Directors for the time being (or the number nearest to but not less than one third) shall retire from office by rotation, and be eligible for re-election. In accordance with this provision, Mr. Wang, John Peter Ben and Mr. Pang Hing Chung, Alfred shall retire from office by rotation at the AGM and, being eligible, offer themselves for re-election.

Brief biographical details of the Retiring Directors proposed for re-election at the AGM are set out in Appendix I to this circular.

#### 3. GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

The resolution set out in item 5 of the notice of the AGM, if passed, will give the Directors a general and unconditional mandate to exercise the powers of the Company to repurchase Shares up to 10% of the number of issued Shares at the date of passing the resolution (the "**Repurchase Mandate**") before the Company's next annual general meeting. A statement explaining the Repurchase Mandate in accordance with the Listing Rules is set out in Appendix II to this circular.

At the AGM, resolution set out in item 6 of the notice of the AGM will be proposed which, if passed, will give the Directors a general mandate to issue Shares and grant rights to subscribe for and convert securities into Shares, before the Company's next annual general meeting, up to (i) 20% of the number of issued Shares at the date of passing the resolution (based on the total number of Shares in issue as at the Latest Practicable Date, being 1,486,017,836 Shares, the mandate would give the Directors power to issue up to 297,203,567 Shares) and (ii) the number of Shares repurchased by the Company subsequent to the passing of such resolution (the "Issue Mandate").

The Issue Mandate and the Repurchase Mandate will continue to be in force from the passing of the said resolutions until whichever the following first occurs:

- (i) the conclusion of the next annual general meeting of the Company; or

# DETAILS OF THE RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED

The biographical details of the Retiring Directors who will offer themselves for re-election at the AGM are set out below:

#### (1) Mr. Wang, John Peter Ben

Mr. Wang, aged 56, has been an Executive Director of the Company since March 2011. He was appointed as Deputy Chairman of the Company in July 2013 and before that, he was the Chairman of the Company from March 2011 to July 2013. He is a director of certain subsidiaries of the Company. He previously held non-executive directorships in Anxin-China Holdings Limited (resigned in November 2014) and MelcoLot Limited (resigned in December 2013), companies listed on the Stock Exchange, and Melco Crown Entertainment Limited (now known as Melco Resorts & Entertainment Limited) (resigned in August 2016), a company listed on the NASDAQ Global Select Market in the United States. From 2004 to 2009, Mr. Wang was the chief financial officer of Melco International Development Limited ("Melco International"), a company listed on the Stock Exchange. Prior to joining Melco International in 2004, Mr. Wang had over 18 years of professional experience in the securities and investment banking industry. His previous employers include JS Cresvale Securities International Limited, Deutsche Morgan Grenfell Securities Hong Kong Limited, Credit Lyonnais Securities (Asia) Limited, Carr Indosuez Asia Limited and Bear Stearns (Hong Kong) Limited. Mr. Wang qualified as a chartered accountant with the Institute of Chartered Accountants of England and Wales in 1985.

Save as disclosed above, Mr. Wang does not hold any directorship in other listed public companies during the past three years and does not hold any other position with the Company or other members of the Group. Mr. Wang has confirmed that he does not have any relationship with any directors, senior management, substantial shareholders or controlling shareholders (as defined in the Listing Rules) of the Company.

Under a letter of appointment dated 10 July 2013, Mr. Wang was appointed as Deputy Chairman and Executive Director of the Company. He is subject to retirement by rotation and re-election at the annual general meeting in accordance with the provisions of the Bye-laws. Mr. Wang is entitled to a director's fee of HK\$180,000 per annum for acting as an Executive Director of the Company. Such fee is determined by the Board with reference to his duties and responsibilities with the Company and the prevailing market conditions.

As at the Latest Practicable Date and within the meaning of Part XV of the SFO, Mr. Wang has personal interests of 161,079,980 Shares. Save as disclosed above, Mr. Wang does not have, and is not deemed to have, any interests or short positions in any shares, underlying shares or interests in debentures of the Company and its associated corporations within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Wang has confirmed that there is no other information that is required to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules and there is no other matter which needs to be brought to the attention of the Shareholders in respect of his re-election.

## DETAILS OF THE RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED

#### (2) Mr. Pang Hing Chung, Alfred

Mr. Pang, aged 55, has been an Independent Non-executive Director of the Company since March 2011. He is also a member of the audit committee of the Company.

He is currently Vice Chairman of Silk Road Finance Corporation Limited ("Silk Road"). He is also an independent non-executive director of MelcoLot Limited, a company listed on the Stock Exchange. Mr. Pang has over 25 years of financial, management and investment banking experience in China, Asia and the United States. Before joining Silk Road, Mr. Pang was the chairman of Standard Advisory Asia Limited and a member of Asia Executive Committee. He was previously the managing director and vice chairman, Investment Banking Division, at BOC International Holdings Limited ("BOCI") where he was also the chairman of BOCI's commitment committee. Prior to joining BOCI, he was the managing director and president, Asia at the US investment banking firm of Donaldson Lufkin & Jenrette.

Save as disclosed above, Mr. Pang does not hold any directorship in other listed public companies during the past three years and does not hold any other position with the Company or other members of the Group. Mr. Pang has confirmed that he does not have any relationship with any directors, senior management, substantial shareholders or controlling shareholders (as defined in the Listing Rules) of the Company.

Mr. Pang holds dual Bachelor of Arts (in Economics) & Bachelor of Science (in Electrical Engineering) Degrees from Cornell University, and MBA Degree from Stanford University Graduate School of Business in the United States.

Under a letter of appointment dated 1 January 2013, Mr. Pang was appointed as an Independent Non-executive Director of the Company for a term of three years (currently renewed to 31 December 2018), which term will be automatically renewed for consecutive term(s) of three years, subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Bye-laws. Mr. Pang is entitled to a director's fee of HK\$120,000 per annum for acting as an Independent Non-executive Director of the Company. Such fee is determined by the Board with reference to his duties and responsibilities with the Company and the prevailing market conditions.

As at the Latest Practicable Date and within the meaning of Part XV of the SFO, Mr. Pang has personal interests of 1,180,000 underlying Shares in respect of share options granted under the share option scheme of the Company. Save as disclosed above, Mr. Pang does not have, and is not deemed to have, any interests or short positions in any shares, underlying shares or interests in debentures of the Company and its associated corporations within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Pang has confirmed that there is no other information that is required to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules and there is no other matter which needs to be brought to the attention of the Shareholders in respect of his re-election.

## EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This Appendix contains the particulars that are required by the Listing Rules to be included in an explanatory statement to enable the Shareholders to make an informed view on whether to vote for or against the resolutions to be proposed at the AGM in relation to the proposed Repurchase Mandate.

#### LIMIT OF POSSIBLE REPURCHASE OF SHARES

As at the Latest Practicable Date, the number of Shares in issue was 1,486,017,836.

Subject to the passing of the resolution granting the proposed Repurchase Mandate on the basis that no further Shares are issued or repurchased before the AGM, the Company will be allowed to repurchase a maximum of 148,601,783 Shares, representing approximately 10% of the total number of issued Shares, at the date of passing the resolution during the period ending on the earlier of the conclusion of the next annual general meeting of the Company or the date by which the next annual general meeting of the Company is required to be held by the applicable laws of Bermuda or the Bye-laws or the date upon which such authority is revoked or varied by a resolution of the Shareholders in general meeting.

#### REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders to enable the Company to repurchase its Shares on the Stock Exchange. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets value of the Company and/or earnings per Share and will only be made when the Directors believe that such repurchase will benefit the Company and the Shareholders.

The Directors have no present intention to repurchase any Shares and they would only exercise the power to repurchase in circumstances where they consider that the repurchase would be in the best interests of the Company and in circumstances where they consider that the Shares can be repurchased on terms favourable to the Company. On the basis of the consolidated audited financial position of the Company as at 31 December 2016, being the date to which the latest published audited accounts of the Company was made up, the Directors consider that if the Repurchase Mandate was to be exercised in full at the currently prevailing market value, it may have a material adverse impact on the working capital position and gearing level of the Company. The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital position of the Company as compared with the position disclosed in the latest published audited financial statements or the gearing level which, in the opinion of the Directors, are from time to time appropriate for the Company.

#### **FUNDING OF REPURCHASES**

Repurchases to be made pursuant to the proposed Repurchase Mandate would be financed out of funds legally available for such purpose in accordance with the memorandum of association of the Company and the Bye-laws and the applicable laws in Hong Kong and Bermuda. Such funds include, but are not limited to, profits available for distribution.

#### EFFECT OF THE TAKEOVERS CODE

Upon the exercise of the power to repurchase the Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases. Such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code. Accordingly, a Shareholder or group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and, depending on the level of increase of the Shareholders' interests, may become obliged to make a mandatory general offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, Mr. Ho, Lawrence Yau Lung and Quick Glitter Limited, a company wholly owned by him, are beneficially interested in 391,712,464 Shares, representing approximately 26.36% of the issued Shares. In the event that the Directors exercise the proposed Repurchase Mandate in full, the interests of Mr. Ho, Lawrence Yau Lung and Quick Glitter Limited in the issued Shares would be increased from approximately 26.36% to approximately 29.29%. Such increase will not give rise to any obligation under Rules 26 and 32 of the Takeovers Code to make a mandatory offer. The number of Shares held by the public would remain in excess of 25% of the issued Shares on exercise in full of the power to repurchase Shares under the Repurchase Mandate. However, the Directors have no current intention to exercise the Repurchase Mandate to an extent as would result in mandatory offer obligations arising.

- (bb) (if the directors of the Company are so authorized by a separate resolution of the shareholders of the Company) the number of shares of the Company repurchased by the Company subsequent to the passing of this Resolution (up to a maximum equivalent to 10 per cent. of the number of shares of the Company in issue at the date of passing this Resolution), and the authority pursuant to paragraph (a) of this Resolution shall be limited accordingly;
- (c) for the purposes of this Resolution:

"Relevant Period" means the period from the passing of this Resolution until whichever of the following first occurs:

- i. the conclusion of the next annual general meeting of the Company;
- ii. the expiry of the period within which the next annual general meeting of the Company is required by the applicable laws of Bermuda or the bye-laws of the Company to be held; and
- iii. the revocation or variation of the authority given under this Resolution by ordinary resolution of the shareholders of the Company in general meeting.

"Rights Issue" means an offer of shares of the Company or issue of options, warrants or other securities giving the right to subscribe for shares of the Company, open for a period fixed by the directors of the Company to holders of shares whose names appear on the register of members of the Company (and, where appropriate, to holders of other securities entitled to the offer) on a fixed record date in proportion to their then holdings of such shares of the Company (or, where appropriate, such other securities) (subject in all cases to such exclusions or other arrangements as the directors of the Company may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of, or the requirements of any recognised regulatory body or any stock exchange in, any territory applicable to the Company)."

(II) "THAT the directors of the Company be and they are hereby authorised to exercise the powers of the Company referred to in paragraph (a) of the resolution set out as Resolution (I) in item 6 of the notice of this meeting in respect of the shares of the Company referred to in subparagraph (bb) of paragraph (b) of such resolution."
